1) Rules and Regs - Proposing formal reorganization of the language and exceptions for Chelsea points to be added to Article XIII to read:

Article XIII Golf Play

<u>13.4 Chelsea Points. For every Round of Golf played, a Member will be charged one Chelsea Point.</u> <u>The following are exceptions to this rule</u>

- a) Participants will not be charged any Chelsea Points for attending any Spring Run Charity Event.
- b) For Spring Run Member/Guest Events, your Guests will not be charged Chelsea Points <u>as</u> <u>long as the "Guest" is not Member.</u>
- c) January through March, Members may also sign up for a round of golf after 3 pm with no Chelsea points assessed.
- d) April through December, Members may sign up for a round of golf after 2 pm with no Chelsea points assessed
- 2) Rules and Regs Amending Rules and Regs to include newly approved Florida Statutes regarding Electronic Communication and Balloting

Article IV Owner Mailing Addresses; Notices

4.3 <u>Notices</u>. Except as otherwise specifically provided in the Governing Documents, all notices or other communications required to be given or made hereunder shall be in writing and shall be delivered by hand or mailed by registered or certified mail, return receipt

requested, postage prepaid. Notices delivered in person shall be deemed received upon actual receipt, and notices mailed shall be deemed received three days after deposited in the mail in accordance with this Paragraph. Notices to the Association shall be delivered to the address of the Club Facilities. Notices to a Member shall be addressed to the Member at the address filed in accordance with Paragraph 4.1. <u>or may be sent electronically, if the member provides an</u> <u>email address to the Association for communications from the Association.
